#### PEEL I

Scholarship Program -- Below are the July 2006 quarterly reports submitted to the PEEL Advisory Committee by the eight PEEL I scholarship recipients. Darlene asked me to share these reports with the Commission. Two of these individuals, Honore Bray and Kathryn Holt, have completed their graduate programs and have earned the MLIS degree.

Stipend Program -- Helena Public Schools has hired Jeanne Morigeau to be the full-time librarian at Jim Darcy School. Jeanne has a recent MLS degree from Texan Woman's University and has been employed by the Clancy Community Library. Bitterroot Public Library received three applications for the Youth Librarian position; two did not have MLS degrees as required and one was not interested because of the salary. The library will re-advertise the position and try for more applicants. The director is unwilling to raise the salary for the stipend position because she does not think that would be fair to other library staff.

#### PEEL II

Scholarship Program – The ten scholarships awarded by the Commission in May have been accepted and signed agreements are in place. The students are getting enrolled for the first quarter that begins this fall. Photos of the recipients are now posted on the greatcareer@yourlibrary website.

# PEEL I July 2006 Quarterly Reports from Scholarship Recipients:

#### Honore Bray

I have received the final notification to look at the transcript to see if it is correct and then I will receive a copy when they are final. The diploma came in the mail and it was a glorious day! Now, life goes on as normal, working each day at Missoula Public where I intend to stay as long as they want me. I will be working with Sue Jackson to set up a mentoring program and as part of a project for my last semester I set up a Journal Discussion Group that can take place for CE Units. I am very excited to have had the opportunity to be a part of this program and would love to contribute as much in return as possible.

#### Kathryn Holt

I completed two more courses toward my MSLIS degree at Drexel University during the spring quarter, which ended 6/10/06. I completed requirements for INFO 673 – Resources in Social Sciences and INFO 688 – Instructional Role of the Information Specialist, and was informed by the instructors that I received an A in both courses. I maintained a 4.00 GPA throughout the MSLIS program, and have now completed all requirements for the MSLIS degree at Drexel University. A copy of my transcript was mailed to Sue Jackson on June 30, 2006.

#### INFO 673 - Resources in Social Sciences

This course focused on the study of major information resources in the social sciences, including history, geography, political science, sociology, anthropology, psychology, demography, economics, and education. The course emphasized bibliographic organization, collection building, user needs, and reference service. I found the course to be particularly valuable as a means of enhancing my reference service skills and awareness of print, database, and other online subject resources. Creating a subject guide was a major requirement of the course.

### INFO 688 – Instructional Role of the Information Specialist

This course examined the instructional role of the information professional. The course emphasized the planning, implementation, and evaluation of instruction for the purpose of information education. Understanding effective instructional design for teaching information literacy skills was a major focus of this course. My understanding of the instructional role as a high school librarian and information specialist was significantly impacted by this course, and I feel prepared to articulate that instructional role while collaborating with teachers to enhance content-area instruction and students' information literacy skills.

I am already in a tenured position as the Havre High School Librarian, and plan to continue in this position as a teacher-librarian for the Havre Public School district.

I have enjoyed participating in the online MSLIS course delivery via Drexel University. While the course work has been rigorous, the online format allowed me to actively participate in discussions, group projects, etc. while working as a full-time high school teacher-librarian and also teaching classes at MSU-N. The course professors communicated regularly with students, were accessible, and participated directly in guided class discussions.

Being highly motivated and very organized, following a regular routine regarding coursework and participation in class discussions, and keeping a daily planner for recording and tracking requirements and assignments helped me be successful in an online graduate program learning environment. Grading is criteria-based and requirements are explicitly presented in the Drexel MSLIS courses.

I enjoyed the online delivery format, appreciated the flexibility that online classes offer, and experienced academic success in meeting the requirements of the Drexel MSLIS graduate program, maintaining a 4.00 grade point average throughout the program. I am very grateful for the opportunity I had to participate in the PEEL Scholarship Program, which made it possible for me to earn the MSLIS degree at Drexel University. #### Judy McKenna

It looks like I'm on the home stretch with my program at Texas Woman's University (TWU). I'm currently enrolled in a Reference class and I just submitted my final paper last Friday. TWU requires a Portfolio in lieu of a thesis to obtain the Master of Library Science degree. Three faculty members review my portfolio and as long as two of them agree the Portfolio is either a Pass or a Fail. I will know by July 5, 2006 whether my Portfolio passed.

I signed a contract to be one of the Library Media Specialists at Chief Joseph Middle School in Bozeman, so I have a library position. I spent the past two weeks participating in a Teaching American History grant with other teachers in the Bozeman School District to prepare me for working with the teachers and students.

## **Kathy Mora**

I am now almost half way through my masters program! I received an A in both of my Spring classes and am taking two classes this summer.

Research Methods and Analysis focuses on learning how formal research is conducted and developing skills for analyzing reports and research with a critical eye. There is also work with using specific statistical mathematical functions when conducting research. The class involves much group discussion and has been very interesting, especially when a group of six people are trying to understand and come to agreement on concepts that most of us have never worked with before.

The final project for this course is a group research report that will involve gathering use statistics in a public library through observation and then comparing those with the demographic makeup of the community where the library resides. The knowledge gained from this class will be valuable in the future when the need to survey and analyze library users, services and the community arise in order to facilitate short and long term planning.

We have started to use voice chat in this class for the first time and it is a great tool for class interaction. We have the option of typing responses, but everyone has a microphone and the environment is much closer to that of a traditional classroom.

My second class is *Internet Applications, Services, & Management for Information Professionals*. This class is a study of the history of the Internet and its applications and how they have evolved into the World Wide Web that is so prevalent today. Although I have had experience with most of the concepts presented in the class, it has still been an interesting experience. We have worked with FTP, Telnet and other applications that are unfamiliar to most people in the class. It has been a reminder that our library users also may not have the knowledge that we do and that we should always keep their needs in view when planning services and library instruction.

There has been a lot of discussion of the impact of the Internet on libraries and issues on policy that have come with it and that are still evolving. As always, it's interesting to talk with other people in the program and learn what their libraries are doing (although we do have a few people in the class that have never worked in a library). One of the projects for this class will be a research paper, which I plan to write on the issue of filtering in public libraries.

I'm enjoying both classes this summer, although it's been difficult to stay motivated (it is summer after all!). But, I am doing well overall and look forward to classes in the fall.

#### Fred Noel

I finished my final semester of classes on June 10<sup>th</sup> and passed Management of Technical Services with an "A". All my course work is finished and my cumulative GPA for the program is 3.95. Fantastic.

Libraries in American Society – This course was not what I expected, but has turned out to be quite interesting. In the beginning there was a great deal of philosophy about information and organization. We then moved on to how computers developed.
