

With this budget we purchase many materials and continue to update our collection so that we will have a current collection. We deselect many materials due to lack of use and purchase new materials in there place. That said we do not have a budget or space to fill the need of every patron that uses our library. Interlibrary Loans help us with our home-schoolers, we are able to keep up with and supplement their curriculum. Our last count included 30 home-school families.

We have a large number of academic books requested by long distance learners doing research.

Bicentennial Library of Colstrip understands that there are many small libraries in Montana like us that are in remote areas. Colstrip is thirty two miles from the interstate. We have many patrons from Ashland, Lame Deer, Birney and even Brodas that use our library. Interlibrary Loans is a valuable service that people in our and the surrounding communities have come to depend on.

Subject: Legislative Funding for Libraries

First, I hate to see libraries lose funding to help with ILL's, but the system has been inequitable for years and not very helpful for small libraries, so it probably is time for revamping what the funds from the legislature are spent for. Therefore, I am definitely in favor of the new legislation.

I agree that part of the money from the legislature should go to offset the increases in OCLC costs, because most of us need OCLC no matter what it costs, and local money and Federation money isn't going to keep up with the inflation there.

However, I disagree with the Fulfillment Task Force on the distribution of the remaining funds. My library is part of the Montana Shared Catalog, and I really believe in the existence and the concept of the Shared Catalog. That said, I have to state emphatically that I do not believe in further money spent on the MSC. The Shared Catalog is already getting a sizable chunk of the funds spent on Montana libraries, including most of the federal LSTA funds available plus Montana State Library funds spent on personnel, materials, fiscal handling, etc.

Many libraries in Montana, especially the smaller ones, cannot raise nor justify the funds necessary to join the Shared Catalog -- and for most of them, that is not going to change in the foreseeable future. Many will benefit from assistance with OCLC, but only as the cost savings can be explained to their boards and county or city officials when they are explaining that they will no longer be getting ILL reimbursements to help with postage and staff time. I am concerned that those officials will see the end of ILL reimbursement as a reduction in budgets and subsequently start calling for measures like charging for ILL, which is contrary to our roles as public libraries.

Because we are only as strong as our weakest links, these smaller libraries need our attention. It has been suggested that a staff member be added to the State Library to help them, but our State Library Consultants like Suzanne Reymer are already doing that well. Instead, I would like to see funds go toward actual reimbursements or direct funding for essentials.

I would like to see the State Library Consultants like Suzanne identify all the small public libraries which meet certain criteria -- budget amount per capita served under a certain figure, for example -- and then take 50% of the legislative funding and divide it among those libraries. I have heard people disparage funding of this sort because it "enables" public officials to give the libraries less, but I know for certain that in most cases that simply isn't true. Instead, in the majority of the cases, those public officials are giving the library what they can and simply cannot meet the real needs of the library. The libraries could be required to account for the spending of the funds and to indicate how the funds have enhanced service to their patrons and communities.

NOTES OF IMPORTANCE, INCLUDING CONCERNS AND FRUSTRATIONS:

- ILL is an integral part of Montana libraries and we have been encouraged to share our resources and have the opportunity to borrow from Montana libraries and the rest of the world
- This project was started by the Montana State Library and many patrons have benefited from this program
- By ending funding for ILL, the Montana State Library is placing the burden on libraries that are facing budget cuts
- ILL reimbursement was a fair way to allocate funds. Libraries that shared their books were also reimbursed and all libraries had the option to participate and receive reimbursement
- The Liberty County Library has contacted OCLC about IFM (Internal Fee Management).

- It is frustrating to see the Montana State Library start new programs when it fails to continue
 with existing programs that most of the libraries are using and that patrons have come to

Dear Marsha:

I am writing to voice an opinion shared by many librarians regarding the proposed change to the library statues regarding reallocation of current funding for ILL.

While I support the broadening of the allocation purpose to include funding for OCLC, I oppose the diversion of ILL funds to the Montana Shared Catalog.

ILL is a base program used by all libraries which, ideally, would be state supported so that all libraries could participate without overburdening local resources. Support for ILL transactions has been on a steady and precipitous decline at the same time as costs have dramatically risen.

In order to reach the widest range of libraries, allocation of state funding to support OCLC would be the most equitable use for these funds, not the shared catalog.

Darlene,

I am writing in response to the proposed revisions to the 2009 Information Access Montana Legislation. I do agree that the revisions need to be made and if asked by my Senator or Representative I will tell them I support the changes.

If the legislation is changed, and if an administrative rules process is initiated to repurpose the current funding (\$200,000), I would prefer that funds go to the statewide OCLC bill only. But I would really like to see some funds directed to the following: open source library systems (ILS).

The Why

Over the last few years the major ILS systems have been bought up and are owned by 3 companies (SirsiDynix, Innovative Interfaces and Ex Libris). Who knows when one company may merge with another and what they will continue to support. These systems are all very proprietary while the growth of the Internet, and other web based systems have pushed forward the growth of open source system design.

The Sidney-Richland County Library has chosen not to join the MSC primarily due to ephemeral and high ongoing costs. But our Follett system is limited and Follett has not delivered on promised technology such as SIP2/NCIP. Currently they are moving to an upgrade called Destiny. So soon they will no longer offer support to our present version. The cost to move to Destiny coupled with the not making significant protocol upgrades has had me researching ILS systems and I keep coming back to open source systems particularly Koha. We have used other open source products in the past and have continued to monitor the progress of products such as Koha. We have just kind of been waiting until our Follett system has run its course.

To keep it simple here are the three main why's;

1. Less money - Open source even with support services (LibLime is a company that supports Koha) is cheaper. Some of the initial costs of migrating may be comparable to a commercial vendor if you hire a company to do it for you. But long term it would be cheaper. For one thing you aren't paying for software licensing. I believe a consortium of libraries in British Columbia went with Evergreen, also an open source ILS, and have lowered their total costs significantly.

2. Features- Evergreen and Koha, the two leading open source ILS systems offer features better than commercial systems. Montana has been trying to offer equal access for all Montanans through ILL, the MSC and now library cards that can be used at collaborating libraries. But to really deliver equitable access our libraries need to be able to deliver **affordable** and seamless

communication between all libraries. Some libraries have state of the art, some are on systems that are not standards compliant and some aren't automated at all. Clearly we need to look at other solutions besides commercial vendors. I don't believe MSC with SyrsiDynix is an option.

3. Customizable- The huge plus is that development is driven by the libraries which in turn is really driven by our customers. Funds would really go toward the development of the software which would make the life of it a lot longer than a commercial vendor product. I read somewhere that the life expectancy of a commercial product is only around 3-5 years. If one library designs an upgrade or works with a company to develop a solution within an open source ILS, all libraries, with that system (Koha) get the upgrade. Now that's resource sharing! That doesn't happen with a proprietary vendor solution. Open source systems such as Koha are customizable and flexible for all sizes and types of libraries.

The How

I would suggest that the Networking Advisory Council be given the charge to examine, plan and make recommendations regarding open source ILS systems (Koha and Evergreen) and other open source software (Vufind-library system mashes with web 2.0) which may be relevant. But we also need to keep on top of developments with OCLC and WorldCat local and how that relates to ILS's. Possibly some of the repurposed funds could go towards grants for libraries wishing to migrate to an open source ILS like the grants that are available to join Sirsi and the MSC. The grants would be for initial set up costs and migration and come through the Network Advisory Council. Repurposed funds might even support an MSL staff person to guide libraries moving to open source. OR—if funds are repurposed for OCLC and the MSC that MSC funds be used for a pilot of new members (a collaborative group of smaller libraries) to migrate to Koha or other open source ILS. Then as the "kinks" got worked out the new MSC2 could join the current MSC. By that time enough data will have been collected that the current MSC may also decide to move to open source.

Could an open source ILS system be the answer for an affordable long term statewide ILS system? Other states are already moving in that direction. In reading the discussion on Wired November 11 (MSL staff attending Ohio conference), I agreed with much of their sentiment. Here were Bruce Newell's comments;

"I am reminded that focus and the ability to execute our dreams walk hand-in-hand with innovation. Without one of these legs (focus, execution, innovation) on our three-legged stool, we fall over. And trying new things, with the possibility of failing, takes courage. I guess that gives our stool four legs."

I think with these four legs we should move forward to execute our dreams and repurpose funds towards helping libraries move to an open source ILS.

The interest and concern of the Montana State Library and the Commission to listen to the library community is very much appreciated. Thank you for taking the time to explain the 2009 Legislative changes and giving all of us the opportunity to express our ideas and be a part of this legislative process.
