Re: Montana Land Information Act Budget and Account Update

The Financial Report is that which was approved by the Montana State Library Commission at their October meeting. Note that the MLIA funds accounted for represent legislative authority, not the amount budgeted in the current FY 15/16 Land Plan. The breakdown of spending for MLIA funds can be found in the FY 16 Digital Library Budget.

It is our intent to share this information with the Council, rather than the summary information previously provided, in order to improve transparency for audit purposes. This budget also better reflects the larger funding picture, including other sources of funds on which the State Library relies to fund our GIS work.

Though the current FY 16 budget shows an amount in excess of the \$552,000 authorized in the Land Plan for coordination and MSDI work we are confident that, through additional contracts and our move to ESRI managed services, we will be able to further reduce our reliance on MLIA funds this fiscal year.

As a reminder, MLIA funds not expended remain in the MLIA Account for future use.
