The Montana Geospatial Information Plan was originally opened for public comment from May 27- June 26. The Montana State Library received four public comments via the online survey and one public comment submitted via email. The July 11th, meeting was cancelled due to a lack of Council quorum and public comment for the Plan was reopened until 12:00 p.m., September 5, 2025.

Page 7 at paragraph 1.2, "Implement a scalable geospatial architecture to support the of the MSDI & geospatial information." Should there be the word data here or eliminate "the of"? On this same page at paragraph 1.3, "Collaborate and coordinator with stakeholders from state, local, tribal, federal, nonprofit, private, university, and professional associations on the development of standards, best practices, tools, and training opportunities for the preparation and implementation of NSRS modernization. Might sound better as coordinate, and universities. Also, on this same page at paragraph 2.1, "The GIS Coordinator, Theme Leads, MSDI Working Groups, & Council will work to define datasets, value measures, & assess value measure for each MSDI Framework Theme. Does this sound repetitive? I know one is definition, and one is assessment, just sounds repetitive to me. Maybe this wording, "...work to define the value measures and datasets and the assessment of the value measures for each..."? Thank you for all you do. I know local government benefits greatly from all the hard work.

Thank you for the opportunity to comment on the draft FY25–27 Montana Geospatial Information Plan. The plan clearly shows a strong commitment to improving the state's geospatial infrastructure, and it's encouraging to see steps already being taken to restore MGIA funding through House Bill 192 and recording fee adjustments.

That said, I would like to see the plan adopt a stronger position toward exploring funding diversification. With federal and state budgets under pressure, there's always the risk that programs like MGIA could face cuts down the line. Rather than waiting for that to happen, this could be a good time to explore supplemental options. I'd like to suggest including a resilience strategy in the plan to help protect the program from future funding uncertainty.

Examples include: public-private partnerships with industries that rely on spatial data, establishing endowment or trust fund models for long-term geospatial investment, developing revenue from specialized services for commercial users or private entities and stakeholders, and expanding research collaborations with Montana's academic institutions to access competitive federal and private grants. Partnerships and/or cost sharing with other state agencies, local governments, and tribal entities and community-driven data collection efforts may also serve to broaden both participation and resilience.

The alternative funding sources mentioned are compatible with MSL's policies and statutory authority and could help safeguard from future funding uncertainty. I appreciate the opportunity to provide input and applaud the forward-looking work of the MGIA planning team.
