Since protests against the Solid Waste Disposal District was far less than the required amount of 51% necessary, the following resolution was hereby made:

RESOLUTION CREATING
REFUSE DISPOSAL DISTRICT

WHEREAS all requirements preliminary to the establishment of a Refuse Disposal District have been satisfied, and all protests thereto have been found to be insufficient:

BE IT RESOLVED that a Refuse Disposal District encompassing all of Jefferson County, Montana, is hereby created for the purpose of the disposal of refuse within said Jefferson County. Reference is made to the Resolution of intention to create Refuse Disposal District adopted by the Jefferson County Board of Commissioners on August 7, 1973.
