Establishment: There is hereby created a Board to supervise the affairs and management of the Public Library, which Board shall consist of five (5) members to be appointed by the Chief Executive and confirmed by the Council of Commissioners. All members of the Board must reside within the jurisdictional area of Butte-Silver Bow. The members of this Board shall hold office for three (3) years and at least one (1) such member must be appointed at the first regular meeting of the Council of Commissioners of each year. Provided that at the first meeting of the Council of Commissioners after passage of this Ordinance, the Chief Executive shall appoint five (5) members of such Board, two to serve for one (1) year, one (1) to serve for two (2) years and two (2) to serve for three (3) years. Members may be removed for cause by a twothirds (2/3) majority of the confirming authority upon written charges and after public hearing. Vacancies on the Board shall be filled for the unexpired term of any member whose term becomes vacant in the same manner as members are originally appointed and confirmed. At the first meeting after appointment the

Board shall elect a Chairman and Vice-Chairman

	majority of the Board and signed by the

	tions in conflict herewith are hereby repealed.
