The following motion was made by Alderman
 Keller and duly recorded and passed:

That as the Mayor feels he has been negligent
 in not giving the Council a fair opportunity
 in passing on the Petersen proposition it is
 moved that Peter Petersen's bill for \$150 for
 salary for May and June, 1917, be allowed.

The Treasurer's reports for March and April
 were read and referred to the finance committees
 which approved of the reports, which were then
 adopted. Such reports showed the following balances
 in the treasury: March: General Fund 2190.53
 Water: 1354.89 Sinking 512.14, Total 4057.06
 April: General: 2087.98, Water 1375.51, Sinking 512.14.
 Total: 3972.13

The Marshal's report for March, 1918, was read
 and rejected.

The following ordinance was introduced
 by Alderman Keller and duly passed:

Ordinance No. 64.

An Ordinance establishing a Free Public
 Library in the Town of Twin Bridges, Providing
 for the levying of an Annual Tax for a Library
 Fund for such library and Providing for the
 Management of said library.
 Whereas, at an election held in the Town of Twin
 Bridges, County of Madison, State of Montana, on
 the first day of April, 1918, the electors of said Town
 authorized the Town Council of said Town to
 establish a free public library in said Town,
 and to levy an annual tax of not to exceed three
 mills on the dollar on all taxable property in
 said Town for a library fund for said library.
 Be it therefore ordained by the Town Council
 of the Town of Twin Bridges:

Section 1. There is established a free public library in the town of Jurn. Bridges, to be known as the Jurn Bridges Public Library.

Section 2. The Mayor shall, with the advice and consent of the council, appoint a board of three trustees of said library. The members of said board shall hold office for one year, or until their successors are elected and qualified; they shall take the oath of office required of other town officers and shall file a bond in the sum of five hundred dollars, to be approved by the council, conditioned for the faithful performance of their duty. Any vacancy in the board of trustees shall be filled by the Mayor with the advice and consent of the council.

Section 3. The said board shall appoint one of its members chairman, and one of its members secretary, of said board. It shall keep a record of all its proceedings, which record shall at all times be open to the inspection of the council or finance committee of the council. The board shall make all necessary and proper rules and regulations for the running and conducting of the library, not inconsistent with this ordinance; it shall have the power to receive and purchase all books and other things necessary for a library and make all expenditures necessary for the maintenance of such library, consistent with the money on hand in the library fund; it shall have power to appoint a librarian and assistants, to provide a place for the keeping of said library and to make all proper rules and regulations for the use of books and to preserve the same from loss or destruction.

Section 4. For the purpose of creating and maintaining a library fund the council shall levy an annual tax, not exceeding three mills on the dollar on all taxable property in the town. Such tax when collected shall be placed in the library fund of the town and shall be used for the purposes only of supporting and maintaining such library and for the purchase of books and other necessary things therefor. All money when collected or received for the use of the library shall be deposited with the town treasurer, who shall

invest the same under the direction of said board. No money shall be paid out by said treasurer, from such fund, except on an order or warrant from such trustees who shall have exclusive power to make contracts and expenditures for the support and maintenance of the library and the purchase of books and other things thereof.

Section 5. If any person shall wilfully, maliciously or unlawfully take or carry away any book, magazine, paper or other property of the library, contrary to the rules and regulations of the board of trustees, or shall mutilate, destroy or injure any book or other property of the library, or shall interfere with or disturb any person while in charge of the library or any person using or reading in said library, he shall, upon conviction, be fined in any sum, not less than one nor more than ten dollars.

The vote on said ordinance was as follows:
Ayes: Pitcher, Keller, Ruppel, Rott and Stocker.
Nays: None.

The meeting of the old council was then adjourned and the new council met. Present: His Honor, the Mayor and Aldermen Pitcher, Rott, Keller, Stocker and Mountjoy. The Alderman Paige was elected president by acclamation.

The Mayor appointed the newly elected aldermen to fill all places on the committees occupied by retiring members from their respective wards, except that Alderman Keller was appointed on the street and alley committee in place of Alderman Ruppel. The following officers were appointed and unanimously confirmed: Glenn A. Pritchett, as marshal, Hester A. Thompson, as Police Magistrate and Byron Comfort, as Treasurer. The bond of Byron in the sum of two thousand dollars was approved and ordered filed. C. D. Barker was appointed health officer and unanimously confirmed.

The council then duly adjourned.
