

REGULAR MEETING

April 26, 1966

The Town Council held it's regular second meeting of the month on this date. Mayor Wilson called the meeting to order with members Christensen, Hoehne, McLeod and Murfitt answering present to the roll call. Hamilton and Cunningham were absent.

The minutes of the previous meetin were read and approved by all.

A letter from the Montana Aeronautics Commission, addressed to the County Commissioners, was read by the Clerk. The Council went on record, on motion of McLeod and seconded by Murfitt, as supporting the Granite County Commissioners in establishing a General Aviation Utility Airport in the Philipsburg area.

The Council was advised by the Town's Consulting Engineers, Hammond and Everly, that the Town's application for Federal Aid for Storm Sewers, Water lines, and Street Improvement has been on file in Washington long enough for the Council to start writing letters to Mansfield, Olson, and Metcalf, asking them to start supporting the processing of this application. The Clerk was ordered to write these letters at the dictation of Zane Murfitt.

The resignation of Warren Coble as Police Judge was accepted by the Council. Coble's resignation was due to illness. The law provides for a Justice of the Peace to rule during the absence of a Police Judge with the fees still going to the City.

A representation of the Senior Women's Club was present in connection with the Library which they sponsor; the Council went on record as to the fact that the Library is owned by the Town of Philipsburg.

It was brought to the attention of the Council by the Town Treasurer that there is a water bill against the new Town Hall building in the amount of \$51.25; also the amount of \$2.50 for water and 50 cents for sewer against the Howard Naef property. The Council made motion to write off the water and sewer bill on these two premises which now belong to the Town. Motion was made by Murfitt and seconded by McLeod, with all in favor.

An application for a building permit to add a room onto the property of Charles Cantero was approved by the Council.

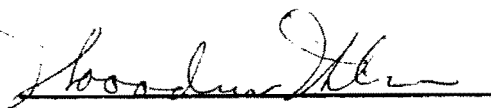
A discussion on a trade of equipment with Charles Neuman of Georgetown Lake was held. At a motion made by McLeod and seconded by Christensen the Council agreed to trade the Town's end loader for another end loader belonging to Neuman, with Neuman paying, in addition to the trade, the sum of \$500.00.

Basil Kennedy, State Auditor, made mention that a Special Improvement District might be set up to increase the area of the street cleaning and make the cost city wide. Attorney Sheehan is to read the law on this matter..

Henry Clift, local contractor, appeared before the Council and gave a price on the time and material that it would require to plaster the ceiling in the garage of the new Town Hall. The figure given was \$156.00. The Building Committee is to work on this and the Council will give Cleft an answer at their May 2nd. meeting.

The Council authorized Marshall Standall to make a reasonable charge to anyone asking him to get rid of their dogs for them.

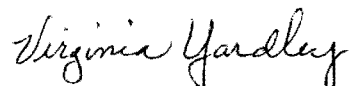
A motion for adjournment was made by Murfitt, seconded by Hoehne. All were in favor; meeting adjourned.



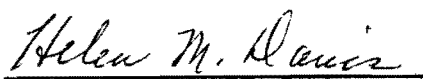
