. Upon motion duly made and carried the above appointments were confirmed by the Council; .

The Indemnity Bond of the First National Bank of Polson to the City of Polson was read considered approved and upon motion duly made and carried all members voting in favor of said motion said bond was ordered filed with the City Treasurer;

The Clerk was instructed to publish further notice about the use of water for sprinkling, and to call attention to use of water during fire;

. Upon motion duly made and carried all members voting in faror of said motion the clerk was instructed to advertise for bids for the laying of water mains as per instructions from Engr. Faucett said bids were to be filed with the City Clerk on or before June 23rd. 1919 at 8 P.M.

. This being the time set for the considering of bids for work in Special Improvement District No 4 the clerk was ordered to open bids on file, the following bids were received.

AN ORDINANCE PROVIDING FOR A PUBLIC LIBRARY PROVIDING FOR THE MANAGEMENT MAINTAINANCE AND CONTROL OF SAME AND CREATING AN EMERGENCY.

- BE IT ENACTED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA.
- SECTION 1. That there is hereby established in the City of Polson a free public library to be known as the "Polson Public Library"
- of three (3) Trustees, who shall be appointed by the Mayor, by and with the consent and advice of the City Council and who shall hold their offices for a term of one two and three years and until their successors are appointed and qualified and any vacancy occuring in the Board of Trustees at any time, by death, resignation, removal from the city or otherwise, shall be filled in like manner, and such person appointed to fill a vacancy shall hold his office for the unexpired term. The Trustees shall take and subscribe an oath of office, to be fil#ed with the City Clerk. The Trustees shall not receive any compensation whatever for their services as Trustees of the Library.
- SECTION 3/ The Board of Trustees shall have full control and management of the Library. They shall select and appoint a Librarian and such other assistants and helpers as they may deem necessary. The Trustees shall adopt rules and regulations to govern the Library, the use of books pamphlets and periodicals therein. They shall have power to receive donations of books, pamphlets and periodicals for the use of the library, and to take and receive donations, bequests and devises for the use and bentition of the library. They shall purchase books, phamplets and periodicals for the library with any money at their disposal.
- Claims for rent against the library when allowed by the City Council shall be paid by warrants drawn on the Library Fund which fund is hereby created and established, and to which the annual library tax when collected shall be credited as well as all donations of money and other sources of revenue. No money shall be drawn from the Library Fund except for rent of Library and incidentals. It is hereby made the duty of the City Treasurer to submit to the Board of Trustees of the Library a monthly statement of the condition of the Library Fund. The Board of Trustees shall make an annual report to the City Council at its last regular meeting in the month of June of each year, of the workings of the library during the past year, the receipts and disbursements to and from the Library Fund; and make an estimate of the amount required for the said Library for the next fiscal year, and make such recommendations as they may deem of importance to the betterment of the library.
- SECTION 5. The Board of Trustees on entering on the duties of their offices shall elect such officers as they may deem necessary, one of which shall be a chairman of the said board, and shall keep a full and complete record of their proceedings, which shall be open at all times to the inspection of the City Council or any committee or member thereof. upon renting of any building they shall submit to the City Council their estimate of the rents which aught to be paid and thereupon the City Council shall fix said rents which shall be paid monthly by warrants drawn upon the Library Fund upon the audit of the Trustees and allowance of the City Council.
- SECTION 6. The City Council shall make an annual levy withing the limits as provided by law, for the support and maintainance of the said Polson Public Library, and the revenues derived therefrom shall be vredited to the Library Fund.
- SECTION 7. The Board of Trustees is hereby prohibited from contracting any indebtidness other than rent of building in excess of the amount of cash in the Library Fund.
- SECTION 8. Any person who shall by loud or unusual noises or in any other manner disturb the peace in the Polson Public Library or near the same so as to disturb the peace of the occupants of the said Library shall be deemed guilty of a misdomenor, and upon convistion thereof shall be fined in any sum not exceeding three hundred dollars.

- SECTION 9. Any person who shall deface destroy cut write or otherwise injure any of the books, phamplets, periodicals, floors, entrance wall or furniture of the Library shall be deemed guilty of a misdomenor, and upon convistion thereof shall be fined in any sum not exceeding three hundred dollars; and it is hereby made the duty of the City Council or its City Attorney, to prosecute in the Police Court a civil action for the damages done by such person.

 SECTION 10. All acts and parts of acts in conflict herewith are
- SECTION 11. Whereas it is necessary for the immediate preservation of the public peace, health and safety that the City of Polson have a free public Library, at as early a date as possible, an emergency is hereby declared to exist and this ordinance shall, therefore be in effect from and after its passage and approval.
