ESTABLISHING A COUNTY FREE LIBRARY.

WHEREAS a petition was filed with this Board on November 7th, 1946, praying for the conversion of the present County Free Library located at Scobey, Montana, to a County Free Library and thereby establishing a County Free Library; and,

WHEREAS the said petition appears to be legal and sufficient in every respect; and,

WHEREAS a notice of hearing of said petition was published according to law and a hearing of said petition was held at the time and place specified in said notice of hearing at which said hearing a number of interested taxpayers were present in behalf of the establishment of the said County Free Library and no one appearing in protest and it appearing that a County Free Library is desirable.

NOW, THEREFORE, BE IT HEREBY RESOLVED that a County Free Library is hereby established with the understanding that Daniels County will assume the responsibility for the maintenance and operation of the same beginning July 1, 1947.

This resolution unanimously adopted this 3rd day of March, A. D. 1947.
