#### AGREEMENT FOR LIBRARY SERVICES

THIS AGREEMENT, made and entered into this 14<sup>th</sup> day of June, 2011, by and between ROSEBUD COUNTY, MONTANA, a body corporate and public, with its principle office located in Forsyth, Montana, and TREASURE COUNTY, MONTANA, a body corporate and public, with its principle office located in Hysham, Montana;

#### WITNESSETH:

- That Treasure County does not maintain a public library and Treasure County residents have access to and use the public libraries located in Rosebud County, Montana;
- That the Montana State Library has distributed per capita and per square mile state aid allotments to all Montana counties for the fiscal year 2012;
- That Treasure County desires to enter into an agreement with Rosebud County for library services and as such, desires to forward to Rosebud County all library state aid allotments for fiscal year 2012 as and for payment for such library services; and
- That Rosebud County agrees to continue to provide library services to Treasure County residents and to accept Treasure County's library state aid allotment beginning **July 1, 2011 and ending June 30, 2012**. This agreement may be extended annually.

#### MEMORANDUM OF UNDERSTANDING

THIS AGREEMENT made and entered into this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 1986, by and between ROSEBUD COUNTY LIBRARY, operated under the direction of the Rosebud County Library Board of Trustees, by Rosebud County, a political subdivision of the State of Montana, hereinafter referred to for convenience of reference as "LIBRARY", and the COLSTRIP BICENTENNIAL LIBRARY under the direction of an Advisory Board hereinafter referred to for convenience of reference as "ADVISORY BOARD".

WITNESSETH:

WHEREAS, the Parties have agreed upon terms and conditions for the furnishing of library services, in consideration of their mutual promises hereinafter given,

NOW, THEREFORE, the Rosebud County Library and Colstrip Advisory Board hereby agree as follows:

- 1. The Library agrees to continue to provide library services for the residents of Rosebud County to the extent permitted and under the authority of the laws of the State of Montana. Colstrip shall continue the operation of the library in its present location and shall be known as the COLSTRIP.

  BICENTENNIAL LIBRARY, a branch of the Rosebud County Library.
- 2. Colstrip agrees that all books, (excepting therefrom memorial books and existing cash balances), and other library materials, furnishings and supplies that are currently in its possession will be property of the Library.
- 3. The number of hours open will be set by the Library.
  A concerted effort will be made to provide hours in response to community interest, including evening and weekend access.

- 4. The Library shall make every effort to employ qualified staff as needed. Salaries will be set by the Rosebud County Library Board of Trustees as directed by State Law.
- 5. All utilities and all reasonable maintenance thereof, equipment purchases and repairs and supplies, is to be a part of an annual operating budget prepared with the advice of the Advisory Board.
- 6. The Advisory Board agrees that any rental or lease payment from the library for the property described as situated on Lots \_\_\_\_\_ must be directed back to the Rosebud County Library General Fund on a monthly basis.
- 7. The cleaning and upkeep of the library and premises shall be administered by Advisory Board.
- 8. Advisory Board agrees that the selection of books for the Colstrip Bicentennial Library will remain their responsibility. Advisory Board further agrees that all book orders are to be reviewed and approved by them prior to submitting to the Library for approval.
- 9. Advisory Board further agrees that an annual library operating budget for the Colstrip Bicentennial Library will be prepared by the Colstrip Advisory Board prior to each fiscal year end to be submitted to and approved by the Library. Upon approval by the Library, the Library agrees to incorporate the Colstrip Budget as a part of the total annual library operating budget for Rosebud County recommended to the Board of County Commissioners.
- 10. This Agreement may be terminated for cause if either party fails to perform its obligations hereunder. In the event termination of this Agreement results in dissolution of the consolidation of Advisory Board and the Library, all property, materials and equipment acquired through County funds by the Library shall be property of the Library.
