Special meeting . October 29th.1924.

The Council of the City of Glendive, Montana, met in special session at the City Hall in said City, on Wednesday, October 29th.1924 at the hour of 2;00 o'clock P.M.

Members all present as follows;

- Alderman Haskell,

- " Whistler,
- " Gates.

The meeting was called for the purpose of giving consideration to the wholesale industrial power rate submitted by the Eastern Montana Light & Power Co., for power and light at the City of Glendive Pumping Station;

The Company's rates are as follows ;

This was submitted by the Mayor M.G.Danskin , who also stated that according to these rates ,figuring on the basis of consumption used during 1923, a saving of approximately \$2691.35 on pumping and \$190.00 on lights could have been effected.

Objection was entered by Attorney S.M.Doyle and members of the Council over the above rates submitted, they preferring to amend the commercial and industrial power rate in effect at this time, so that the last step should read "over 125 H.P. 02.75 cents per K.W.H instead of 03½ cents per K.W.H.;

Mr. E.L Brown Manager of the Light Co., contended that the rate as submitted was the best possible offer they could make;

Mr. Brown guaranteed that the lines and meters would not in any event be moved from their present location; Also fur-

Regular meeting Oct. 20th. 1924

The Council of the City of Glendive, Montana, met in regular session at the City Hall in said City on Monday, October 20th. 1924 at the hour of 8;00 o'clock P.M.

Members all present as follows;

Minutes of the last regular meeting read and duly approved Messrs F.P. Flemming, Roy Eustrm and Albert Johnson came before the Council, representing the local Merchants Association of this City and requested that a suitable ordinance be adopted to control peddling etc; This matter was discussed pro and con and after due consideration by the Council the following Ordinance, Numbered 389, entitled "AN ORDINANCE ON THE REGULATION OF PRIVATE BUSINESS, INCLUDING LICENSES, AND DECLARING AN EMERGENCY" was introduced by unanimous consent;

Said Ordinance was then read twice throughout and once by title; Moved by Alderman Haskell seconded by Alderman Whistler that said Ordinance No. 389 be passed and adopted as read;

The aye and naye vote being called resulted as follows;

Alderman Grulke-----aye.  
" Haskell-----aye,  
" Whistler-----aye,  
" Gates-----aye, Nays-----none.

Thereupon said Ordinance was declared passed and adopted and thereupon in open session of the Council, the same was submitted to the Mayor, who did sign and approve said Ordinance and it was attested to by the Clerk.
