## RESOLUTION

BE IT RESOLVED, That a County Free Library be and is hereby established and the necessary tax be levied at the time and in the manner that other levies are made for the current fiscal year.

Commissioner Edsall seconded the motion for adoption. Upon roll-call, all Commissioners voted "Aye", whereupon the Temporary Chairman, Kester, declared the resolution adopted.
