Attached is a list of the 43 Montana libraries that have qualified for the 1999 Collection Management Honor Roll. These libraries have met the requirements established by the Commission, which include having a current collection management policy on file at MLS, having a minimum of fifty percent of the library's holdings included on the OCLC/WLN database, and actively adding/deleting the library's holdings on the database during the last three years.

The Collection Management Honor Roll recognizes all types of libraries and their efforts to manage a variety of collections. This year's list includes seven academic libraries, twenty-eight public libraries, seven school libraries, and one special library.

At this time I request that the Commission accept and approve the 1999 Collection Management Honor Roll. I would also request that a member of the Commission read the Honor Roll at the Awards Lunch on Friday, April 28th during the Montana Library Association (MLA) Annual Conference in Billings to give public recognition to the libraries that have achieved this status. MLA has asked for the list to be read at the awards ceremony, but, in the interest of time, that distribution of the actual certificates be done following the luncheon. The Honor Roll will be on display during the Conference.
