## **PUBLIC VALUE SUMMARY BY PROGRAM**

### **Program 1 - Two Membership Meetings**

#### **Narrative**

Two membership meetings will be held in FY 2018. The spring meeting will be a two day meeting. The business of the Federation will be conducted and a full day of training for Trustees and Librarians will take place. Expenses will be covered for a Public Library Trustee and a Librarian from each of the active Public Libraries. Expenses for one member of a School or Special Library will be covered. Mileage to the meeting is at the expense of each library.

The fall meeting will be conducted via a conference call. CE will not be available during the fall meeting. All Public Libraries must send a representative to both meetings to qualify as an active member. If a Public Library is not represented due to an emergency the executive committee will determine if the library will have active or inactive status. It is beneficial that the Montana State Library staff and State Commissioners participate in the meetings.

The coordinator will:

- Arrange meetings
- Create and distribute appropriate notices and documents for the meetings
- Attend at least 3 State Library Commissioners meetings
- The Federation Coordinator Library will receive \$1000 to help defray the costs for travel and other Federation Expenses.

Included in each years business:

- Conduct the business of the federation, including election of officers, in accordance with its by-laws
- create the POS for the following year in a timely manner with membership participation.

#### **Public Value**

Ronan Library District - Allows patrons to easily access manuals for maintaining and repairing their own vehicles.

Ronan Library District - Allows patron computer use, printing, etc...tied to each patron individually. Envisionware has so many benefits for patrons and staff, it is difficult to list them all.

Darby Community Public Library - To improve library/internet/computer/printing services to the public.

North Lake County Public Library - The North Lake County Public Library District completed its digitization of the Flathead Courier/Lake County Leader newspapers through December 2012 with our 2018 Tamarack Federation monies. The newspapers from 1980 forward are available for the public to view at the Library on the public computers; prior issues are available at [www.MontanaNewspapers.org](http://www.MontanaNewspapers.org). Our hope is that digitization of these news articles and images will provide ready access for our community members to the complete history of the area, enabling a more educated and fully functional population.

Plains Public Library District - Patrons will benefit from having up to date software and computers to use for job searching, resumes, skype, email, taxes, etc. Plains is a community of very poor individuals and they use the computers at the library because they cannot afford to own one. By the library providing up to date computers they can be at the same computers that larger communities have and utilize also. We know this has help them file their taxes as well as helping them apply for an getting new jobs.

Plains Public Library District - Public can use to find jobs, information on health issues, and to have internet access.

North Valley Public Library - The benefit of the Montana Shared catalog is patron access to library material throughout the State. Sharing materials with one another easily allows us to help patrons in their lifelong learning. In addition the libraries can be successful in meeting this mission better because through MSC we have access to highly skilled IT staff that maintain and train on the catalog and cataloging expertise.

Thompson Falls Public Library - Patrons are able to download ebooks and audio books 24/7 with their library card from their home, the library, or anywhere wi-fi is available. Because Montana libraries join together in this program, the cost is affordable and we are able to offer this service that patrons expect. Our usage continues to increase every month.

Thompson Falls Public Library - This program allows patrons and staff to search and find individual items in the collections in our library as well as any other Montana Shared Catalog member library collection. Patrons can view their account, place holds, and renew items. With the BookMyne App, patrons can do all of this easily from their tablet or smart phone. Because Montana libraries of all types join this consortium, the cost of our ILS is affordable for us.

## **Program 4 - Expanding and sharing collections**

### **Narrative**

Libraries may purchase and share collection materials in accordance with the Tamarack Federation Collection Policy, including creating Book Club kits. To encourage and assist in sharing collections, libraries may choose to apply funds to courier and or postage costs.

### **Public Value**

Mineral County Public Library - Allows better patron access to services, as well as technical support

Whitefish Community Library - Being a member of the Partners' consortium enables libraries to share materials. To provide access to over a million items, especially for a small library like Whitefish, is an valuable service. Without funding for the courier service we would be required to mail several hundreds of items a month. This would prohibit many libraries from taking advantage of a service that is so beneficial to our patrons.
