RE: Support for the Hexagon and Prism Logo for the Montana State Library

Dear Commissioners,

I am away on annual leave today and unable to attend the commission meeting as it conflicts with some family plans. I am writing in support of the hexagon and prism logo for the Montana State Library that was recently developed by executive staff at the Montana State Library in conjunction with Hoffman-York. When the new hexagon and prism logo was revealed to staff its symbolism had an immediate positive connection with me.

The Montana State Library is Montana's warehouse of geographic information and hexagons are widely used in geographic information system mapping because they tessellate or tile together perfectly in covering any surface. Hexagons also have the unique property of being the mapping unit requiring the shortest side length, which is why bees use this shape in the walls of their honeycombs, and they pack within the vertices of one another so that they can be systematically nested at different scales. In short, the hexagon is a perfect shape to represent information housed at the State Library.

Similarly, the Montana State Library is composed of a number of programmatic areas that are well represented by a prism as the white light of the entire State Library is composed of a full spectrum of program areas. We are individual programs that serve Montana citizens in different ways, but together we are the Montana State Library.

I am personally attracted to the prism because its properties were discovered by Sir Isaac Newton, one of the greatest scientists of all time. While the wonders of a rainbow are surely appreciated by all Montanans and, in fact, any person who has ever lived, Newton designed the experiment that

documented how wavelengths of light are separated into individual colors. When I showed the new logo to my son, who just finished 5th grade, he immediately said, "Dad, this reminds me of Newton's color wheel." He then went on to describe how a spectrum of colors on a wheel when spun seemingly magically appears white to the observer as the shutter speed of our eyes is not fast enough to separate them out. Among other things, Newton's discovery has led to our understanding that the universe is expanding, and that water and other chemicals essential to life are present on planets orbiting stars many light years from us.

Those are the connections that the hexagon and prism logo make for me, but it is clear to me that the hexagon and prism logo can provide a limitless set of meaningful connections to patrons of the Montana State Library. What could better represent the Montana State Library than limitless opportunities that can be opened to patrons who use information provided by the Montana State Library?


To the MSL Commission:
