The Montana State Library (MSL) is pleased to share the Federal Fiscal Year 21 Library Services and Technology Act (LSTA) award final report. The financial award from the Institute of Museum and Library Services to MSL through the formula-based Grants to State Program for this period was \$1.24M.

### What is LSTA?

The Libraries Services & Technology Act (LSTA) Grants to States Program is the largest grant program run by the <u>Institute of</u> <u>Museum and Library Services</u> (IMLS). It provides funds to State Library Administrative Agencies (SLAAs) using a population-based formula set by federal law. SLAAs determine goals and objectives for the funds in their statutorily required <u>fiveyear plan</u>. Each SLAA must also conduct a <u>five-year evaluation</u> of library services based on that plan. To view Montana's priorities, visit the <u>state's profile page</u>.

### With support from LSTA...

15,250 learners combated the "summer slide" by attending 550 educational events delivered using the Collaborative Summer Library Program in summer 2022. 420,000 Montanans were served by the Montana Shared Catalog, granting access to 3.5 million library books and media statewide.

Library consultants made **67%** more site visits than the previous year, answering **847** questions to help local staff solve problems and implement services.

Talking Book services for the blind and print disabled connected 1,774 patrons with 109,735 digital books, 76% of the year's total checkouts.

# LSTA 21 expanded information access

Montana provided Talking Book services to **1,774 patrons** who cannot read standard print due to a visual, physical, or reading disability. Members loaned braille and audiobooks **143,887 times.** 



#### 44,129 unique patron from 54 Montana counties

borrowed e-books, audiobooks, and magazines from MontanaLibrary2Go. The **66,658 items** held by the consortium **circulated 1.5 million times**.



### thousand

pageviews delivered by the Montana History Portal connected Montanans with the state's rich history and culture.

The courier transited **482,495 books** and other library media around the state to fill patron requests placed via Montana Shared Catalog Sharing Groups, supporting affordable and efficient resource sharing.





**4,617 library programs** targeted at kids age 0-5 were attended by **76,414 children**. MSL educated librarians on research-based early literacy techniques so that they can partner with families and caregivers to build a love of learning in Montana youth.

Montana Shared Catalog support staff addressed **1,669 technical support cases** from **148 libraries**, and the knowledge base received **54,296 views**, streamlining support so that local library staff can focus more on service to the public.

#### **Planning for the next five years**

Montana State Library hired a third-party evaluator to measure progress toward the goals outlined in Montana's 2018-2022 Five-Year Plan. Through a competitive bidding process, QualityMetrics was awarded the contract. The evaluator assessed the efficacy of the State Library's activities in advancing its goals, and developed key findings and recommendations to help shape the next Five-Year Plan. Through their research, QualityMetrics found that Montana had achieved or partially achieved all five goals, noting that additional progress would be made in the remaining two years of the plan. QualityMetrics recommendations in conjunction with data and feedback from library directors, Core Services Committees, and library federations were used to write the Montana State Library's 2023-2027 Five-Year Plan. The new plan and the identified objectives will commence with the 2023 award period.
