- If you do not have a microphone, you can call in on a phone.


#### Video

## **2023 Legislative Session**

- House Bill 91: Revise State Aid to Public Libraries passed
  - Tribal college libraries eligible for state aid
  - Per capita amount increases to \$.50
  - State aid extended through June 30, 2029
  - Will require changes to administrative rules
  - Its not to soon to start talking about the impact of state aid funding

## **2023 Legislative Session**

- House Bill 359: Prohibit minors from attending drag shows passed
  - Expressly prohibits drag story times in libraries
- House Bill 234: Revise dissemination of obscene materials to minor laws passed
  - Final version of amended bill has little affect on public or school libraries
- Numerous bills that could have impacted library funding failed.

## **2023 Legislative Session**

- HB 543 for elections held after July 1, 2023 information about increases in property taxes must be included on ballot
- HB 724 requires posting of agenda and public notice electronically
- HB 890 probably won't impact libraries requires governing boards of cities and counties to record meetings and make them available to the public
- SB 117 cannot use donations for conducting elections. Only public funds may be used.

### **Change in Administrative Rules of Montana (ARM)**

- Public library standards degree requirement; budget growth requirement; define hardship; define deferral process;
- State aid amend formula to include tribal college libraries
- Resource sharing review need for 50/50 split between OCLC and MSC funding
- Federations clean-up and removal of archaic terminology in administrative rules' process

#### 2023 Montana Public Library Standards


