Federation Study Recommendations

- Commission discussion and further action
 - Commission recognizes the importance of federation funds for libraries
 - Commission recognizes the value of supporting training and networking for trustees and librarians
 - Commission finds the structure of federations cumbersome
 - Commission directed staff to continue to study the structure of federations
 - During the August Commission meeting, staff will work with the Commission to create a new charge for the Federation Study Task Force.

 - Includes in \$400,000 for hot spots
 - -\$36,000 for History Portal Digitization (up from \$6,000)
 - -\$65,000 for the Courier (up from \$15,000)

- Look for the Commission in Circle, Montana on October 11, 2023



FY 22 Public Libraries Statistics now available

Did you know?

- Montanans use libraries. While still slightly below counts documented pre-pandemic, Montana observed a significant rebound in library visits this past year.
 - Montanans visited public libraries 2.5M times in FY 2022, an increase of 53% from FY 2021.
- 38% of Montanans hold a public library card which grants access to physical and digital collections, totaling over 2.8M titles statewide.
- Visitors seek internet access.
 - The public used library computers 292K times and connected to library Wi-Fi 1.5M times. Over the past five years, Wi-Fi sessions doubled.
- Patrons turn to the library for trusted information.
 - Montanans asked library staff 460K reference questions, and 50K citizens received one-on-one technology support.
- Families build literacy in partnership with libraries.
 - 236K people attended educational library events. Notably, Montanans ages 0-5 and their caregivers attended programs 76K times.
- Montanans borrow books for education, information, and recreation.
 - Readers of all ages borrowed library books and other media 5.1M times. Together, they borrowed 23% more titles than the previous year, another indicator of post-pandemic recovery

Public Library Standards – Now Open!

- Public library directors are encouraged to submit the public library standards.

2023 Montana Public Library Standards

Public libraries receiving state payments need to complete this form to indicate their compliance with the public library standards. Libraries that do not meet a standard will be given an opportunity to explain why they do not meet the standard and what their plan is for complying with the standard in the future.

Change in Administrative Rules of Montana (ARM)

- Public library standards degree requirement; budget growth requirement; define hardship; define deferral process;
- State aid amend formula to include tribal college libraries
- Resource sharing review need for 50/50 split between OCLC and MSC funding

- Timeline:
 - July 2023
 - Task force sat and initial charge given
 - July through September
 - Research, discussion, recommendations review by library community
 - October 2023
 - Draft ARMs to Commission
 - November 2023
 - Public comment period, pending Commission action
 - December 2023
 - Commission adopts final ARMs
