At the request of the Commission, the following report summarizes the MSL Fall Workshop, hosted in Great Falls, September 18-19, 2023. Targeted at library directors, staff, and trustees, the Fall Workshop delivered continuing education on a variety of library-focused topics. The State Library offers the event every other year to provide an affordable training experience, accessible to Montana libraries of all sizes. Because presentations cover more Montana-specific topics and allow for networking with librarians serving nearby communities, attendees often report that the workshops are more applicable to their careers than larger national conferences.

This year, 72 people attended (54 librarians, 5 trustees, and 13 state library staff).

## Post-attendance Evaluation

Montana State Library administered a post-attendance survey which received 61 responses.

- 98% learned something by participating.
- 93% feel confident using what they learned.
- 95% plan to apply what they learned.
- 95% think applying what they learned will improve service to the public.
